WHEREAS, said application was approved by the District and construction approval granted subject to all applicable rules and regulations of Clackamas County and Clackamas County Service District No. 1, and the construction plans approved with conditions by the District and are hereby made a part of this Bond and specific reference is now made to all of the terms, provisions, specifications, rules and regulations, and requirements set forth, declared and provided in such construction approval;

NOW, THEREFORE, if the Principal herein shall faithfully and truly comply with the terms, provisions, conditions, stipulations, rules and regulations, and requirements of said approval and constructs all improvements as required, and shall in all respects faithfully keep and observe all of the foregoing, then this obligation shall be void, otherwise to remain in full force and effect. Further, as part of the covenants herein, in all respects, whether the same be enumerated herein or not, the Principal shall faithfully comply with all terms, provisions, conditions, stipulations, rules and regulations, and requirements of said construction approval, and shall indemnify and save harmless the District, the Board of County Commissioners, its officers or agents, against any direct or indirect damage or injury which may be suffered or claimed by any of them, or any injury to persons or property during the operation of said Principal under the construction approvals and shall indemnify and make whole the District for any damage it suffers resulting from the operations of said Principal, and this obligation is hereby included as part of the Surety's obligations hereunder.
